OWNER: Jefferson County hereby gives notice that sealed bids are being requested for the following Bid Packages as part of the Jefferson County Main Highway Shop Project:

The work for which bids are asked includes the following:

SCOPE OF WORK:

The project scope is for new 83,700 SF building construction to house the operations of the Highway Department, Fleet Division, Administration, along with associated yard operations and storage functions on a new site. The total construction budget (excluding design and owner costs) is approximately \$13.5 million.

BIDS: Individual Bid Package sealed bids shall be submitted on Bid Form included in Bidding Documents and is to be addressed to:

Bidders should note on the outside of the envelope which bid package they are submitting.

All bids are to include Bid Bond per specification requirements. Bid Bond shall not be less than 10% of the base bid amount, or combined bid amount, in the form of a bid bond or certified check made payable to Jefferson County.

The contractor will be responsible for complying with all local, state, and federal regulations.

BIDDING DOCUMENTS:

Electronic Bidding documents of Drawings, Project Manual and other bidding documents will be available through the Construction Manager, Maas Bros. Construction Co., Inc. All bidding contractors using Electronic Documents are responsible for the viewing/downloading of the correct documents for the purpose of providing a sufficient bid. As holders of these documents, bidding contractors are acknowledging their responsibility to obtain any addenda or other materials prior to bidding of the project. Because the Owner, Barrientos Design & Consulting, and Maas Bros. Construction Co. have no control over the means of printing of these documents, the bidding contractors accept the responsibility of verifying that they have all project bidding documents and that they have been printed correctly.

CONTRACT SECURITY: All bidders shall submit, via alternate on the Bid Form, the cost to provide a Performance Bond and a Payment Bond acceptable to Jefferson County, WI and Maas Brothers Construction Co., Inc.

BID WITHDRAWAL: No bid shall be withdrawn for a period of sixty (60) days after the scheduled opening of the bids without the consent of the Owner, Architect and Construction Manager.

BID AWARD: The low responsive and responsible bidder will be recommended for contract award on May of 2014. Jefferson County reserves the rights to reject any and all bids, waive any informalities in bid or bids, or to accept the bid or bids which best serve the interests of Jefferson County. Bids will be awarded within sixty (60) days of bid due date.
