Call to Order

The meeting was called to order by ICC Chair Russell Kottke at 9:30 a.m.

The Secretary confirmed the requirements of the WI Open Meetings Law were met.

Adoption of Agenda

Motion by Dodge County, second by Green Lake County to approve the agenda – Approved.

Approval of Previous Meeting Minutes

Motion by Dodge County, second by Green Lake County, to approve the minutes of the November 2009 meeting of the Intercounty Coordinating Committee.

Legislative Report

Senator Luther Olsen

- Joint Finance Committee met because they are expecting a \$630 million shortfall in Medicare this year. They may push a \$190 million of the deficit into the next fiscal year.
- Currently town government is responsible for assessments. There is discussion that the counties may be required to do town assessments. Currently there are no funds for this potential new county responsibility.
- New tougher drunk driving laws were passed. It is unclear if the costs will be offset by the new raised fees.

Representative Ed Brooks

- Brooks attended a meeting regarding shifting assessment responsibilities to county government, but many spoke in opposition. No bill has been introduced yet.
- Brooks co-signed a bill stating that an alleged offender's name should not appear on CCAP until they are convicted.

Katie Crawley (Sen. Feingold's office)

- Distributed a handout titled, "Control Spending Now Act" from October 2009.

Wisconsin Counties Association Report

Dave Calendar (WCA):

- Department of Revenue is discussing shifting town assessment duties to the county, but there is no funding (unfunded mandate) and opposition from assessors, WCA, and WTA. Currently there is not sponsor from the bill.
- Representative Gottlieb circulated a draft bill designed to repeal 'maintenance of efforts' for emergency services. The Department of Revenue loosely enforces current law. The WCA is not in favor of the maintenance of effort and agrees it should be repealed.
- Mark O'Connell is not running for governor.

EDUCATIONAL PROGRAM: **2010 Census and Redistricting**

Presenter: Dan Veroff, UWEX Demographic Specialist, Applied Population Lab

Census Day – April 1, 2010 (count of population)

- Expect to see promotion
- Short form only (10 questions)
- First new data before April 2011 for redistricting
- June 2011 all other data

American Community Survey replaces census long form

- Larger continuous survey
- Annual updates
- Adds new questions as needed
- Three million people per year will get the survey.
- Twenty (20) pages

Challenges

- Target population – low income, minority, and renter
- Language barriers
- Lack of cooperation/ distrust of federal government
- Irregular or complex housing

Redistricting data

- Tabulation of race/ethnicity for total population
- Sixty-three (63) races categories. Individuals can chose more than one.
- Data down to census block
- Data accompanied by census maps

Presenter: Steve Miller, Chief, Wisconsin Legislative Reference Bureau

- Districts must be contiguous and compact (not point to point)
- Staff should work to keep files secure
- Start in areas where major population changes have occurred.
- Look for WISE(LR), a redistricting tool from the Applied Population Lab
- County government will have 15 days less days to get their information to the state than last census.
