9. Discuss citizen comment regarding extending speed zone on CTH "B" on the west end of Johnson Creek

The Committee had discussion regarding a segment of CTH "B" on the west end of Johnson Creek. Joe Nehmer, Parks Department, added that this area is more problematic today than it was five years ago. He stated that the Rock River Park and boat launch is more active today than in the past. He stated that the approach to get up to CTH "B" from the park was steep, and that exiting the park had visual and sight distance challenges to the East. He would be interested in seeing a lower speed zone carried out past the west side of the park. The Committee had discussion regarding design change to the entrance and signage. This item will be added to the October agenda. No Motion.

12. WisDOT Bureau of Transportation Safety – Transportation Safety Report & Highway Safety Input

Matthew Aslesen, Regional Program Manager, WisDOT Bureau of Transportation Safety, reported that State fatalities for 2013 were 246, compared to 2012's 296 fatalities. Jefferson County had two fatalities year-to-date, compared to 6 in 2012. He also discussed upcoming legislation and Bills of Interest to the Wisconsin Traffic Safety Community.

13. Wisconsin State Patrol (Greg Jenswold)

Sgt. Jenswold discussed the recent fatality in Lake Mills, stating that inattentive driving and driver error was a factor in the accident. He discussed the garbage truck law change regarding double fines as in construction zones.
