PUBLIC HEARING NOTICE

The County of Jefferson, through its Law Enforcement/Emergency Management Committee, will hold a public hearing on December 18th, 2015, at 8:30 a.m. in room 112 of the Jefferson County Courthouse at 311 South Center Avenue, Jefferson, WI.

Jefferson County will conduct a public hearing regarding its proposed application for Community Development Block Grant Emergency Assistance Program (CDBG-EAP) funds. The public is invited to attend to learn about the CDBG program, help identify additional local housing and community development needs, and comment on the activities proposed to be included in the CDBG application.

Topics to be discussed at the public hearing include identification of total potential funds; eligible CDBG activities, public facilities and housing; presentation of identified housing and community development needs; identification of housing and community development needs by public; presentation of activities proposed for CDBG application, including potential residential displacement and citizen input regarding proposed and other CDBG activities.

Residents of Jefferson County are encouraged to attend, especially residents with low to moderate incomes.
